THE OPERATION OF AN ANIMAL SHELTER AND ADOPTION CENTER THAT PROMOTES AND ENSURES THE WELFARE OF ANIMALS, PROVIDES CARE AND ADOPTION SERVICES FOR HOMELESS PETS, PROVIDES DONOR SUBSIDIZED SPAY/NEUTER SERVICES FOR PETS OF QUALIFYING INDIVIDUALS, PET BEHAVIOR TRAINING, COMMUNITY OUTREACH AND HUMANE EDUCATION. IN 2009, THE KANSAS HUMANE SOCIETY ADMITTED AND CARED FOR 17,448 ANIMALS AND FACILITATED THE ADOPTION OF 7,633 PETS. IN 2009, KHS SAVED A TOTAL OF 8,100 PETS AND THE TOTAL LIVE RELEASE RATE WAS 52%. THE LIVE RELEASE RATE FOR CANINES INCREASED TO 68% - UP FROM 58% IN 2008. THE LIVE RELEASE RATE FOR FELINES INCREASED TO 46% - UP FROM 37% IN 2008. KHS CONDUCTED 6,849 SPAY/NEUTER SURGERIES IN 2009 AND 1,316 OF THOSE WERE FOR LOW INCOME PET OWNERS.
